- 3. The Roll Numbers of candidates short-listed for 2<sup>nd</sup> stage Document Verification (DV) for the post of Trains Manager (Goods) is annexed herewith. Document Verification shall be conducted by the Divisions where the candidates are currently working. The date of DV schedule/time will be intimated by the concerned Divisions.
- 4. Candidates called for DV will have to be declared fit in **A-2 medical category** and must have their graduation qualification entered in their service records before being final empanelled.
- 5. The candidates will have to submit the relevant original documents before the committee nominated for document verification.
- 6. Candidate is required to report on the DV Venue, on the allotted Reporting Date & Time as intimated by the concerned Divisions, without fail. Supplementary DV will not be conducted unless due to administrative decision/exigency.
- 7. The candidate should follow instructions issued by railway officials at the DV venue, regarding maintenance of discipline for smooth conduction of DV. Impersonation/malpractice/indiscipline in the DV will disqualify the candidature and he/she will be debarred from all future railway recruitment.
